Mayor Keeran called the meeting to order.

Roll call was answered by Brown, Beech, Murphy, Spain & Warner. Thompson was absent.

Reports were presented and approved.

UNDER MAYOR:

Mayor Keeran introduced Shiela Hiddleston, Champaign County Health Commissioner. She reported on a complaint they had from a village resident and assured us there was no need to be concerned. She informed us the Flu reports are down and the Health District is going to do a Community Health Assessment on Feb. 20th by phone call which should take approximately 10-15 minutes. Students from Clark State will be making those phone calls. She asked for our support for the 4.10 mill levy which is a renewal.

Mayor Keeran gave his "2011 State of the Village Address".

The mayor also asked that Resolution 11-09-04 (B) be repealed as it no longer is effective.

The Resolution addressed the property on East St and the NECCFD. Murphy made the motion, seconded by Spain all members present in favor. Motion passed. The mayor asked the Council to approve replacing the large pine tree out front with two small ornamental trees on each side of the bell. A motion by Warner to remove the tree, seconded by Brown all members present approved. Motion passed.

The mayor asked Council if they needed everything in their packets. Council agreed we could cut down on the packets, Brown asked for certain ones.

UNDER ADMINISTRATOR:

Administrator Yoder informed council of a community campaign called "Paying Forward and Respecting the Past" The goal is to support local merchants within the village the week of February 13th. The trash pick-up schedule for 2012 was given to Council.

UNDER COUNCIL:

Murphy asked when would be a good time for a work session, it was agreed to hold it on a Saturday at noon. Ted will notify members of the date.

OTHER BUSINESS:

A motion to approve Res 02-07-12A allowing the council president to serve on the NECCFD board in the absence of the mayor or administrator by Spain, seconded by Beech all members in favor.

A motion to approve Res 02-07-12B allowing ODOT pavement legislation of State Route 245 by Beech, seconded by Warner all members in favor.

A motion to approved Ordinance 255 approving, adopting & enacting the American Legal Publishing's Ohio Basic Code, 2012 Edition by Murphy, seconded by Spain all in favor.

Deputy Vernon gave the policing report for January

Cathy Weithman, introduced herself and asked council and those present for their support as she is running for the office of Champaign County Prosecutor.

The Administrator and Mayor answered some questions from Connie Switts.

A motion to adjourn by Murphy, seconded by Spain. Meeting adjourned.
